DECISION ORDER

Appellant herein seeks a review of a determination by the Sacramento Regional Director denying it the status of "election requestor." We view this appeal as a request for reconsideration, however, as appellant, SEIU, Local 411, seeks reconsideration of the ballot eligibility cut-off date established in our unit determination decision.

We do not find the extraordinary circumstances necessitated by our rule 32410. Since, 1) appellant is eligible to appear on the ballot, 2) there is no distinction on the ballot between requesters and intervenors, and 3) the placement of names on the ballot is determined by agreement of the parties or chance we find no disadvantage to SEIU that constitutes grounds for reconsideration.

SEIU, Local 411's appeal is hereby DISMISSED.

Dear Election Requester:

After an initial determination found the showing submitted in support of your election request to be insufficient, an additional time period in which to perfect your showing was granted.

Final review of all showing submitted in support of your petition in the above-referenced case has resulted in the administrative determination that the showing does not meet the requirements of PERB Regulation 41210(c).

Another employee organization has filed a valid Request to Conduct an Election in the above-referenced unit. In order to appear on the ballot in the upcoming election in this case you must file with this office a written request that your election request be treated by PERB as an intervention to appear on the ballot. Any written request to this effect must be received in this office no later than 5 p.m. on February 27, 1980. If no such written request is received by February 27, 1980, this election request is hereby dismissed as of February 27, 1980.

An appeal of this dismissal may be made to the Board itself within 10 calendar days of the date of dismissal by filing a statement of the facts upon which the appeal is based with the Executive Assistant to the Board at 923 12th Street, Suite 201, Sacramento, CA 95814. Copies of any appeal must be concurrently served upon all parties and the Sacramento Regional Office. Proof of service of the appeal must be filed with the Executive Assistant.
